**January 2022**

The government continues to manage the risk of serious illness from the spread of the virus. The Prime Minister announced on 27 November the temporary introduction of new measures as a result of the Omicron variant and on 8 December that Plan B, set out in the autumn and winter plan 2021, was being enacted. As a result, these measures are reflected in this guidance for schools. This advice remains subject to change as the situation develops. COVID-19 continues to be a virus that we learn to live with and the imperative to reduce the disruption to children and young people's education remains. Our priority is for you to deliver face-to-face, high-quality education to all pupils. The evidence is clear that being out of education causes significant harm to educational attainment, life chances, mental and physical health. We have worked closely with the Department of Health and Social Care (DHSC) and the United Kingdom Health Security Agency (UKHSA) to revise this guidance.

<p><b>Staff who may otherwise be at increased risk from COVID 19</b></p>	<ul style="list-style-type: none"> <li>• A workplace risk assessment will be agreed with the Headteacher and advice sought from Occupational Health.</li> <li>• If the risk assessment advises that it is safe to do so, the member of staff should continue working,</li> <li>• If the risk assessment advises that it is not safe to work in school, then alternative working arrangements (including working from home) will be put in place.</li> <li>• School must ensure that the member of staff is able to adhere to any active national guidance on social distancing.</li> </ul> <p><b>Pregnant women who are 28 weeks pregnant and beyond or with underlying health conditions that place them at a greater risk of severe illness from coronavirus:</b></p> <p>If a member of staff is 28 weeks pregnant and beyond, or if they are pregnant and have an underlying health condition that puts them at a greater risk of severe illness from COVID-19 at any gestation, school should take a more precautionary approach.</p> <p>This is because although they are at no more risk of contracting the virus than any other non-pregnant person who is in similar health, they have an increased risk of becoming severely ill and of pre-term birth if you contract COVID-19.</p> <ul style="list-style-type: none"> <li>• A workplace risk assessment will be agreed with the Headteacher and advice sought from Occupational Health.</li> <li>• School must ensure that the member of staff is able to adhere to any active national guidance on social distancing.</li> <li>• Alternative working arrangements (including working from home, redeployment) will be considered and put in place.</li> <li>• Where adjustments to the work environment and role are not possible, and alternative work cannot be founded, the member of staff will be suspended on paid leave.</li> <li>• Advice on suspension and pay can be found in <a href="#">HSE guidance</a>.</li> </ul>	<p style="text-align: center;">M</p>

<p><b>Infection Control within the classroom</b></p>	<ul style="list-style-type: none"> <li>• Staff to discuss hygiene rules and arrangements with pupils at the start of term/upon return to school and refer to these regularly during learning time</li> <li>• Where possible, keep cohorts together throughout the day, including consistent members of staff <b>if possible</b></li> <li>• Staff working across more than one bubble should be minimised wherever possible</li> <li>• Staff should avoid close face to face contact and minimise time spent within 1 metre of anyone</li> <li>• Where possible staff to provide feedback to pupils side by side rather than face to face and use airplay to show PowerPoints (teaching from the back of the class where possible)</li> <li>• Classrooms to be kept well ventilated using natural ventilation (open windows, in cooler weather windows should be opened just enough to provide constant background ventilation and opened more fully during breaks to purge the air in the space. Opening internal doors can also assist with creating a throughput of air. If necessary, external opening doors may also be used. When weather is cold open high level windows in preference to lower and school to offer flexibility to allow additional, suitable indoor clothing. <p>Wearing and Removal of Face Coverings</p>	<p>When wearing a face covering, staff, visitors and pupils should:</p> <ul style="list-style-type: none"> <li>• wash their hands thoroughly with soap and water for 20 seconds or use hand sanitiser before putting a face covering on</li> <li>• avoid touching the part of the face covering in contact with the mouth and nose, as</li> <li>• it could be contaminated with the virus</li> <li>• change the face covering if it becomes damp or if they've touched the part of the</li> <li>• face covering in contact with the mouth and nose</li> <li>• avoid taking it off and putting it back on a lot in quick succession to minimise</li> <li>• potential contamination</li> </ul> <p>When removing a face covering, staff, visitors and pupils should:</p> <ul style="list-style-type: none"> <li>• wash their hands thoroughly with soap and water for 20 seconds or use hand sanitiser before removing</li> <li>• only handle the straps, ties or clips</li> <li>• not give it to someone else to use</li> <li>• if single-use, dispose of it carefully in a household waste bin and do not recycle</li> <li>• once removed, store reusable face coverings in a plastic bag until there is an opportunity to wash them.</li> <li>• if reusable, wash it in line with manufacturer's instructions at the highest temperature appropriate for the fabric</li> <li>• wash their hands thoroughly with soap and water for 20 seconds or use hand sanitiser once removed</li> </ul>			<p>All staff</p>	<p>2.1.2022</p>

<p>First Aid/Intimate care</p>	<ul style="list-style-type: none"> <li>• First aiders will be on site at all times</li> <li>• If a pupil becomes unwell with symptoms of COVID-19 the child should be moved to an unused area of the school (Staff Room) with adult supervision (2 metre distancing) and windows opened</li> <li>• Parents to be contacted immediately</li> <li>• If 2m social distancing cannot be maintained with this pupil, then staff to wear full PPE</li> <li>• If a member of staff becomes unwell with symptoms of COVID-19, they should be moved to an unused area of the school (Staff Room), windows opened and their emergency contact contacted by the office or headteacher</li> <li>• Any space used to accommodate a person displaying symptoms must be cleaned thoroughly at the soonest opportunity using normal detergents and anti-bacterial spray</li> <li>• In any emergency contact 999 prior to contacting parents or emergency contacts</li> <li>• If a person, who is displaying symptoms needs to use the toilet before leaving the site, they must use one of the staff toilets and this should be cleaned and disinfected immediately using standard cleaning products and paying particular attention to touch points. No other person to use the toilet until this has been completed.</li> <li>• First Aiders should wear face masks and if the pupil is coughing, sneezing, spitting or vomiting they should also wear a visor</li> <li>• Office staff or the Headteacher will inform Parents immediately for the pupil to be collected (from the front office)</li> <li>• Any pupil or member of staff who has displayed symptoms must be tested and receive negative results before being permitted back on site (see above guidance)</li> <li>• Any person who has assisted a person who was unwell with the COVID symptoms must ensure that they wash their hands thoroughly immediately afterwards.</li> </ul>	<p>L</p>		<p>All staff</p>	<p>2.1.2022</p>

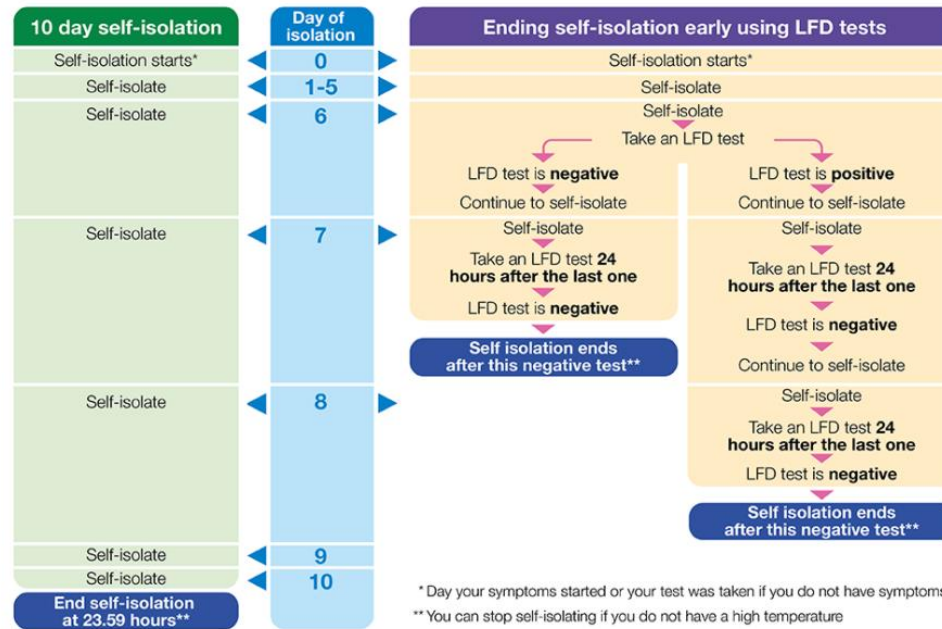
<p>Positive Cases – Track and Trace</p>	<ul style="list-style-type: none"> <li>• Close contacts in schools are now identified by NHS Test and Trace and education settings will no longer be expected to undertake contact tracing.</li> <li>• As with positive cases in any other setting, NHS Test and Trace will work with the positive case and/or their parent to identify close contacts.</li> <li>• Contacts from a school setting will only be traced by NHS Test and Trace where the positive case or their parent specifically identifies the individual as being a close contact.</li> <li>• From 14 December 2021, adults who are fully vaccinated and all children and young people aged between 5 and 18 years and 6 months identified as a contact of someone with COVID-19 are <b>strongly advised</b> to take a <b>LFD test every day for 7 days</b> and continue to attend their setting as normal, unless they have a positive test result.</li> <li>• Daily testing of close contacts applies to all contacts who are: <ul style="list-style-type: none"> <li>• fully vaccinated adults – people who have had 2 doses of an approved vaccine</li> <li>• <b>all children</b> and young people aged 5 to 18 years and 6 months, <b>regardless of their vaccination status</b></li> <li>• people who are not able to get vaccinated for medical reasons</li> <li>• people taking part, or have taken part, in an approved clinical trial for a COVID-19 vaccine</li> </ul> </li> <li>• Children under 5 years are exempt from self-isolation and do not need to take part in daily testing of close contacts.</li> <li>• Pupils with SEND identified as close contacts should be supported by their school and their families to agree the most appropriate route for testing including, where appropriate, additional support to assist swabbing.</li> <li>• Further information is available in NHS Test and Trace: what to do if you are contacted and in the stay at home: <a href="https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance">https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance</a></li> </ul>			<p>All staff and families</p>	<p>2.1.2022</p>

<p><b>Self Isolation</b></p>	<p>Refer to: <a href="https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance/stay-at-home-guidance-for-households-with-possible-coronavirus-covid-19-infection">https://www.gov.uk/government/publications/covid-19-stay-at-home-guidance/stay-at-home-guidance-for-households-with-possible-coronavirus-covid-19-infection</a></p> <ul style="list-style-type: none"> <li>• The self-isolation advice for people with coronavirus (COVID-19) has changed. It is now possible to end self-isolation after 7 days, following 2 negative LFD tests taken 24 hours apart.</li> <li>• The first LFD test should not be taken before the sixth day.</li> <li>• If you have COVID-19 symptoms you should stay at home and self-isolate immediately. You should arrange to have a PCR test as soon as possible. If this PCR test result is positive, you must continue to self-isolate.</li> <li>• If you do not have COVID-19 symptoms, but you have a positive PCR test result, you must stay at home and self-isolate</li> <li>• if you are aged 18 years 6 months or over and you are <b>not fully vaccinated*</b>, and you live in the same household as someone with COVID-19, you are legally required to stay at home and self-isolate</li> <li>• <b>If you are fully vaccinated or aged under 18 years and 6 months, and you live in the same household as someone with COVID-19, you are not legally required to self-isolate.</b> However, you are <b>strongly advised to take an LFD test every day for 7 days</b>, and to self-isolate if any of these test results is positive</li> </ul> <p>(*You are fully vaccinated 14 days after having received 2 doses of an approved vaccine (such as Pfizer/BioNTech, AstraZeneca or Moderna/Spikevax) or one dose of the single-dose Janssen vaccine.)</p> <p>The isolation period is 10 days following the day that you developed symptoms (or if you did not develop any symptoms and had a positive test). - You can take an LFD test from 6 days after the day your symptoms started (or the day your test was taken if you did not have symptoms), and another LFD test on the following day (day 7).
- The second LFD test should be taken at least 24 hours later.
- If both these test results are negative, and you do not have a high temperature, you may end your self-isolation after the second negative test result.
- Pupils may then return to school on day 8 (the day that the pupil developed symptoms or had a positive test is counted as day 0)



If you are isolating because of a positive test result but did not have any symptoms, and you develop COVID-19 symptoms within your isolation period, start a new isolation period from the day your symptoms start.
